Dear Chief Secretary,

As you are aware, India will hold the G-20 Presidency from 1 December 2022 to 30 November 2023. India's Presidency of the G-20 provides a unique opportunity to place our narrative in the global agenda and to showcase India's development and cultural diversity. In order to implement overall policy decisions and arrangements needed for steering India's forthcoming G-20 Presidency in 2022-23, the G-20 Secretariat has been set up in the Ministry of External Affairs by a Cabinet Order dated 15 February 2022.

2. India's efforts to host a unique and impeccably 'Indian' G-20 would necessitate a whole-of-government approach. The support of our States and Union Territories would be critical in hosting a successful G-20 Presidency. In this regard, during my meeting with the Resident Commissioners (RCs) of States and UTs on 24 May 2022 (Minutes of Meeting enclosed), a presentation on the scale and magnitude of the G20 meetings and the logistical and security support sought from states was arranged. It is estimated that during the period of our Presidency, about 190 meetings would be held across India, culminating with the G-20 Summit in New Delhi in October/ November 2023.

3. The engagement and support of the States and UTs would be required at every stage of hosting the meetings, including guidance and facilitation on the identification of venues, accommodation of delegates and cultural events, visits to excursion sites, security, visa and immigration facilitation of the delegates, transport and other logistical arrangements, preparation of delegation kits to showcase the unique handicrafts

and artistic heritage of the state, etc. As a matter of fact, hosting of G-20 meetings in any state would be an opportunity to showcase the state's level of development, infrastructure, culture and heritage to the world.

4. At the G-20 Secretariat, we are in the process of finalizing a draft Calendar of G-20 meetings and the venues involved. An initial draft has already been shared with the Resident Commissioners as it provides a list of the shortlisted cities to enable states to initiate plans accordingly. The final calendar would be shared shortly along with the venues for the meeting, cultural events and planned excursion sites, if any.
5. During the meeting, it was also agreed that to coordinate the arrangements for G-20 Meetings to be held in the States, it would be functionally productive to appoint the following officers:
 - i. A Nodal Officer at the State/UT level for the **Overall Co-ordination** of G-20 meetings. The Nodal Officer may head a Core Coordination Team consisting of officials from the departments of Municipal Administration, Police, Tourism & Culture, and Protocol and/or any other department as deemed necessary.
(The co-ordinates of the Nodal officer may kindly be shared with Joint Secretary (Summits) Shri L Ramesh Babu @jssummits@mea.gov.in).
 - ii. A Nodal officer for **Security Coordination**, heading a Security Coordination Team, which would be responsible for making and coordinating security arrangements for G-20 meetings to be held in the State/UT. The Security Coordination team may include officers from Intelligence, L&O, Traffic, FRRO Office, ISW and /or any other department as deemed fit. The Security Co-ordination Team may work under the guidance of the State DGP.

6. In this background, I would request you to nominate Nodal officers of appropriate seniority to coordinate with the G-20

Secretariat so that we can commence planning and execution of hosting G-20 meeting/s in earnest.

7. Your response by 10 June 2022 would be highly appreciated.

8. I look forward to a productive and meaningful engagement with you over the course of next year and a half as we put in our best efforts to successfully steer India through the Presidency.
