Terms of Reference of the Committee:

- i. Monitoring and trafficking situation in the State, including trafficking through posts and implementation of National Policy on narcotics Drugs and Psychotropic substances.
- ii. Addressing issues of coordination between various Department of State Government on matters related to Drug law enforcement and drug abuse.
- iii. Promoting anti drug abuse awareness at State level,
- iv. Addressing issues of capacity building and training at State level.
- v. Devising and implementing alternative Development programmes in areas affected by illicit cultivation of narcotic crops in the State.
- vi. Monitoring utilization of Funds sanctioned under Assistance to States & UTs for Narcotics Control Scheme.
- vii. Monitoring utilization of funds sanctioned under National Fund for Control of Drug Abuse (NFCDA).
- viii. Gap analysis of forensic capacity in the State and implementation of steps to fill the same.
- ix. Establishment of drug de-addiction habilitation centres in the States.
- x. Any other issue deemed fit.

Frequency: The Committee shall meet on a quarterly basis

Co-opt member: With the permission of the Chair, the UT/State NCORD Committee may co-opt representatives of Departments/ Organizations concerned as members based on the requirement as "Special Invitees"

Terms of Reference of the District Committee :

- i. Exchange of intelligence/ information about trends of drug trafficking.
- ii. Monitoring of illicit cultivation of poppy or cannabis crop in the district.
- iii. Monitoring the progress of investigation in cases having cross-state implications.
- iv. Promoting anti-drug abuse awareness, especially in schools and colleges.
- v. Conducting awareness programmes in the regions affected by illicit cultivation of Narcotic crops in the District.
- vi. Implementing alternative development programmes in areas affected by illicit cultivation of narcotic crops in the district
- vii. Assessing the requirement of equipment of drug detection and submitting proposals for requisitioning of the same.
- viii. Supervision of drug de addiction and rehabilitation centres in the District.
- ix. Any other issued, as deemed fit.

Frequency:- This Committee shall meet every month.

Co-opted member:- With the permission of the Chair, the District NCORD Committee may co-opt representatives of Departments/Organizations concerned as members based on the requirement as "Special Invitees".
