To forward its recommendations to the Bureau to assist the National Energy Conservation Building Code Implementation Committee to develop and revise energy consumption standards for buildings, in terms of energy performance index, zone-wise - hot and dry, warm and humid, composite, temperate and cold climate zones, classification- wise.
3. To create awareness about Energy Conservation Building Code and procedure for erection of Code compliant building.
4. To promote construction of energy efficient buildings ensuring quality and consistency in their constructions having regard to the climatic conditions and needs of the building projects.
5. To promote capacity building of building professionals, developers and contractors to promote energy efficient designs of buildings in close co- ordination with jurisdictional authorities.
6. To undertake performance review of annual work of all Empanelled Energy Auditors (Building) to check their credentials.
