Instructions for Observer:

1. It must be ensured that only candidates with admit cards are permitted inside the venue.
2. Observer should ensure that no cell phone or any other electronic gadgets is in possession of the candidate or the invigilator or any other staff inside the venue.
3. The Observer should ensure that no person other than those deployed for duty is present inside the venue.
4. Random inspection of admit cards may be conducted to check impersonation.

Report of Observer:
