S.O. 92:- In exercise of the powers conferred by section 8 of the Requisitioning and Acquisition of Immovable Property Act, 1952, the Administration of UT of Ladakh hereby direct that for sub-rule (2-A) of Rule 9 of the Requisitioning and Acquisition of Immovable Property Rule, 1953 the following shall be substituted; namely,

"(2-A) In determining the compensation of agricultural and other lands under clause(a) of sub-section (2) of section 8 of the Act, the Competent Authority shall have regard to the following rates of rent with effect from 16.02.2018 to 15.02.2023, which the Government consider minimum for different categories of land in the Union Territory of Ladakh:-
