**Norms of Assistances**

The financial assistance would be limited to Rs 1.00 lakh for organising district level event, Rs. 2.00 lakh for state, Rs 3.00 lakhs for regional level and Rs 5.00 lakhs for National level and Rs. 10.00 lakhs for international level event.

Furthermore, it is also to notify that the proposal will go through scrutiny by the project screening committee (PSC) before approval by Standing finance committee of National Medicinal Plant Board, Ministry of AYUSH, New Delhi.
