Notification

Ladakh, the 22nd of August, 2022.

S.O.100. _ In exercise of the powers conferred by section 3 of Jammu and Kashmir Motor Vehicles Taxation Act, 1957 (XXVI of 1957), as adopted vide S.O.3775 (E) dated 23.10.2020 and in supersession of Notification issue vide S.O._07 dated 26.03.2021, the Administration of the Union territory of Ladakh hereby notifies that: -

1. The Road/Token Tax in respect of new motor vehicles using any public road in the Union territory of Ladakh shall be levied at the rates indicated against each as under: -

a. Road/Token tax for non-commercial vehicles:

S. No	Type of vehicle	Period	Road/Token Tax to be paid
1	Two wheelers with cost up to ₹2.00 lakh.	For first 15 years	One time Road/Token Tax @3% on the original cost of the vehicle excluding GST at the time of purchase/registration of the vehicle.
		After 15 years	Road/Token Tax @0.2% per annum on the original cost of the vehicle excluding GST.
2	Vehicle costing up to ₹10.00 lakh	For first 15 years	One time Road/Token Tax @6% on the original cost of the vehicle excluding GST at the time of purchase/registration of the vehicle.
		After 15 years	Road/Token Tax @0.4% per annum on the original cost of the vehicle excluding GST.
3	Vehicle costing above ₹10.00 lakh	For first 15 years	One time Road/Token Tax @9% on the original cost of the vehicle excluding GST at the time of purchase/registration of the vehicle.
		After 15 years	Road/Token Tax @0.6% per annum on the original cost of the vehicle excluding GST.

b. Road/Token Tax for commercial vehicles:

S. No	Type of vehicle	Period	Road/Token Tax to be paid
1.	Two-wheeler with cost up to ₹2.00 lakh	For first 15 years	One time Road/Token Tax @3% on the original cost of the vehicle excluding GST at the time of purchase/registration of the vehicle.

		After 15 years	Road/Token Tax @0.2% per annum on the original cost of the vehicle excluding GST.
2.	Vehicle costing up to ₹10.00 lakh	For first 15 years	One time Road/Token Tax @6% on the original cost of the vehicle excluding GST at the time of purchase/registration of the vehicle.
		After 15 years	Road/Token Tax @0.4% per annum on the original cost of the vehicle excluding GST.
3.	Vehicle costing above ₹10.00 lakh	For first 15 years	Option-I: Road/Token Tax to be paid one time @9% on the original cost of vehicle excluding GST at the time of purchase/registration of vehicle. Option-II: Road/Token Tax to be paid @9% on the original cost of the vehicle excluding GST in 07 equal annual instalments and each installment to be paid annually within 07 years.
		After 15 years	Road/Token Tax to be paid @0.6% per annum on the original cost of the vehicle excluding GST.

2. Road/Token Tax to be levied on All India Tourist Permit Vehicles:
As per section 3 of Government of Jammu & Kashmir Motor Vehicle Taxation Act, 1957, the Union territory of Ladakh hereby notifies the Road/Token Tax to be levied on All India Tourist Permit Vehicles as under: -

S. No.	Particulars	Road/Token Tax to be levied
1.	All India Tourist Vehicle (Stage Carriage)	₹2000/- per day
2.	All India Tourist Vehicle (Contract Carriage)	₹1500/- per day
3.	All India Tourist Vehicle (Two-Wheeler Bike registered under Rent a Motor Bike Scheme).	₹500/- per day

3. The Road/Token Tax in respect of Motor Vehicles registered/bought from other States/UTs whose age is less than 10 years at the time of re-registration in the Union territory of Ladakh shall be levied road/token tax on pro-rata basis on the life of the vehicle which is 15 years at present and the road/token tax on vehicles whose age is 10 years or more at the time of re-registration in the UT Ladakh shall be the same as applicable to new vehicles.


