

Department of Food Civil Supplies and Consumer Affairs Kargil UT Ladakh

1. Brief information of the department:

The Department of Food, Civil Supplies and Consumer Affairs Kargil (U.T.Ladakh) is came into existence after formation of Ladakh as a new Union Territory in 2019, having under its ambit as Food Civil Supplies and Consumer Affairs, this department is distribute ration commodities like Rice, Atta/ Wheat, Sugar and K.oil among the rationees implementing the Nation Food Security Act 2013 from February 2016 in the whole District of UT Ladakh providing adequate quantity of Stocks dumping in FCS&CA main Godowns and despatching the ration commodities for further distribution on subsidized prices. This department is supply ration at the far flung areas in advance for winter 3 to 6 months, and 26 pony sale outlets the stock of Food grains are procured on the basis of PDS portal basis from the Govern of India through FCI Kargil .

2. Departmental Wings: -

The Department is under the controller of worthy Secretary FCS&CA UT Ladakh, and the Director FCS&CA Ladakh is HOD of both the District Kargil and Leh. On District level the Assistant Director FCS&CA Kargil is supervise with its subordinate staff Chief Inspector along with 10 TSOs in Circle / Block level and 75 Sanctioned store keeper at 191 Sale outlets in District Kargil.

The Department distribute ration commodities like Rice, Atta, Sugar and K.Oil among the rationees who are registered on PDS portal at 191 sale centre located in various parts of the District .

4. Roles and responsibilities :-

- The Head of District level officer is Assistant Director FCS&CA Kargil, presently Mr.SherabGyaltson is on this post, the Assistant Director supervise all the activities and development works to ensure smooth function of the Department. The Assistant Director have power of Budget allocation, drawing and disbursing for draw the payments and dues related to the Department. supply of ration commodities, stocking of winter zone area as well far flung area store are supervised by him.
- Chief Inspector monitors the Allotment of Ration and lifting position from FCI / IOCL as well as despatch/ supply Food grains from Main Store HQ to other entire sale centres of the District on monthly basis. He also monitor online allocation on PDS portal, Annavitran, and look after the work of Supply chain management on portal based on every month.

- c. Tehsil Supply Officer are supervising the work in their respective Circle of every sale outlet to ensure timely getting of ration commodities and its smooth distribution without any shortage / crisis. They also check the Offtake statement and remittance of sale proceed on monthly basis as per allocation. The grievance of public like application for issuance of Ration cards, category change, transfer of RCs, any kind of other related to ration cards of their respective circles are also address by them.
- d. The Store keepers receives the Food grains as per monthly allocation and Distribute it to the rationees on ration cards through POS (Point of Sale) machine at the sale outlets assigned to them. They prepare the monthly sale statement on the basis of distribution of ration and submit the information through Concerned TSO to the Head Office. They also remit the amount of sale proceed in Treasury on monthly basis after duly checked by the concerned TSO.
- e. The Assistant Store keeper assists for running the sale outlets and other activities assigned to them by the Department.
- f. Shali-clerks maintain the PDS as well as Office records. They also assist the office works of Tehsil Supply Officer at the respective Circle.
- g. The Chowkidar, Watchman and Weighman are Class IV employees, they have assigned the work of watch and ward of the stocks and store where they posted and also working in the sale centre under the supervision of Store Keeper of the said store.
- h. Helper are working in the store for maintain stocks of Food grains in good condition during sale and receive the ration at the sale centres

5. Departmental Schemes:-

PHH (Priority house Hold) and AAY (Antyodaya Anna Yojana)

The scheme of PHH and AAY are implemented in accordance with the Nation Food Security Act. 2013, under this scheme, eligible house hold are entitled to food grains at the subsidize price of Rs.3/= per Kg Rice and Atta. The AAY RC Holder also entitled to get Sugar @ 1 Kg per month on subsidizes price fixed by the Central Government time to time.

NPHH (Non-Priority household) the eligible household are entitled to get food grains on subsidize price of Rs.15/= per Kg Rice and Rs.13/= per Kg Atta.

K.Oil (SKO) are also issued to the all category of ration cards at the price fixed by the Govt. time to time.

The department has linked the Ration card with Aadhaar number of the Head of Families and members registered in their ration card, till date 98% Aadhaar have been linked in their respective Ration card.

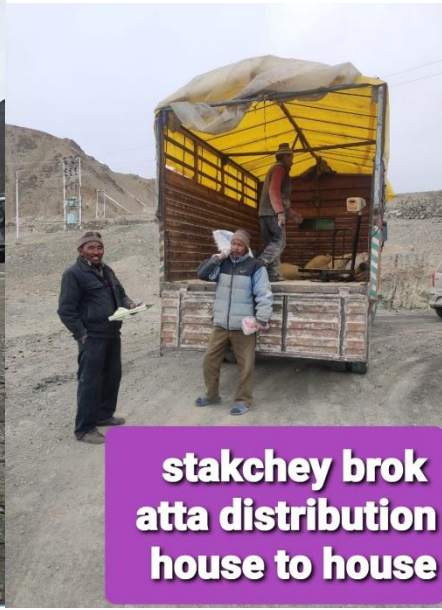

7. PMGKAY (Pradhan Mantri Garib Kalyan Anna Yojana).

The Government of India has released during COVID 19, Rice and Wheat under the scheme of PMGKAY from April 2020 to September 2022 among the PHH and AAY beneficiaries and distributed @ 3500 Kgs Rice and 1500 kgs Wheat on free of cost, which is distributed to the beneficiaries from the sale centres and submit.

Vision: -

The vision of the Department is to reach to every citizen of the District, who will not remain un-registered on the ERCM portal (in their ration card), so that no one left beyond the National Food Security Act 2013 (NFSA) scheme launched by the Centre Government, and the food grains supply at a subsidized rates on ration card.

Mission: -

The Department is bound to supply Ration commodities at all the 191 sale outlets to facility the entitled beneficiaries even in far flung areas and snow bound like Ichoo, Pangbar of BarsooArea, Lungnak, kargayak of Zanskar area, PandrassMatayen of Drass Sub-Division.

- a). Eligible households shall be entitled to food grains under section 3 at the subsidized price not exceeding Rupees 3 per kg for Rice, Rupees 3 per kg for Atta and rupees 1 per kg for coarse grain, the price fixed by the Central Government, from time to time, not exceeding:-
 - i. the minimum support price for Atta price and Coarse grains : and
 - ii. the derived minimum support price for Rice. as the case may be.
- b). Ration card is issued as per survey report time to time by the concerned TSO, Surpanch and block level members as and when required.
- c). To create and maintain scientific storage facilities at the every village and Block level.

Citizen Charter:

The Department is issuing ration cards after registrar their name , parentage, residence particulars on ERCMS (PDS) portal to every household after linked their Aadhar card with RC and aadhaar seeding of family members of respective rationees and distributing ration commodities through POS (Point of Sale) Machine at the sale centre by the concerned Store keeper on monthly allocation basis among the entitled RT holder, at this time the following Nos of ration cards and members have been registered on portal.
