"Constitution Day" is observed every year on 26th November to commemorate the adoption of the Constitution of India.

As a part of the celebrations reading of the preamble to the Constitution of India has to be organized on **26th of November, 2022 at 11 AM** onwards by all offices in the UT Administration of Ladakh, Autonomous Bodies, organizations, Local Self Government institutions, educational institutions etc. Other activities including talks/webinars on constitutional values and fundamental principles of the Indian Constitution may also be organized.

3. Therefore all offices of the Government, Autonomous Bodies and Public Sector Undertakings stationed at Leh and Kargil districts are called upon to organize the reading of the Preamble on the date and time mentioned above.

4. Besides it is also directed that District Magistrate/ Sub Divisional Magistrate/ Tehsildars/ Block Development Officers shall co-ordinate and preside over the function at their respective districts/ tehsils/ blocks in the Union territory of Ladakh by active involvement of the Local Self Government institutions.

THE CONSTITUTION OF INDIA

PREAMBLE

WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a **'[SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC]** and to secure to all its citizens :

JUSTICE, social, economic and political;

LIBERTY of thought, expression, belief, faith and worship;

EQUALITY of status and of opportunity and to promote among them all;

FRATERNITY assuring the dignity of the individual and the **²[unity and integrity of the Nation]**;

IN OUR CONSTITUENT ASSEMBLY this twenty-sixth day of November, 1949 do **HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.**

सामाजिक, आर्थिक और राजनैतिक न्याय,

विचार, अभिव्यक्ति, विश्वास, धर्म

और उपासना की स्वतंत्रता,

प्रतिष्ठा और अवसर की समता

प्राप्त कराने के लिए,

तथा उन सब में व्यक्ति की गरिमा और

राष्ट्र की एकता और अखंडता

सुनिश्चित करने वाली बंधुता बढ़ाने के लिए

दृढ़संकल्प होकर अपनी इस संविधान सभा में आज तारीख 26 नवंबर, 1949 ई. (मिति मार्गशीर्ष शुक्ला सप्तमी, संवत् दो हजार छह विक्रमी) को एतद्वारा इस संविधान को अंगीकृत, अधिनियमित और आत्मार्पित करते हैं।
