**Whereas,** the Ministry of Health and Family Welfare, Government of India vide letter: No. U. 14014 /16/2022-ME-II (FTS No. 8169243), dated: 28th October 2022, 06 MBBS and 02 BDS, seats were allocated to the Union territory of Ladakh under Central Pool MBBS & BDS seats-allocation for the year 2022-23.


