
Pursuant to the approval of the President, Rajya Sainik Board, sanction is hereby accorded to the appointment of Colonel Lobzang Neema (Retd.) as Director Sainik Welfare Department-cum-Secretary Rajya Sainik Board Ladakh in the Ladakh Sainik Welfare (Gazetted) Service with immediate effect, in terms of the Guidelines issued by the Government of India, Ministry of Defence, Department of Ex-servicemen Welfare vide No. F.No.22(5)/2013-D (Res-II) dated 26<sup>th</sup> December, 2013:-

**Terms of engagement**

- i. **Period of engagement:** The engagement shall be for a period of three years from the date of issuance of the Appointment Order and can be further extended for another two years subject to the satisfactory performance of the concerned officer.
- ii. **Remuneration/Salary:** The pay of the officer shall be fixed on the Last Pay drawn by him from the defence services, as per the Pension Payment Order on the date of retirement minus the basic pension and commuted portion of pension plus allowances.  
Leave/TA as admissible to temporary Government employees.
- iii. The officer shall report to the Home Department, UT Ladakh.
- iv. **Termination of engagement:** As engagement is purely on contractual basis, same will be subject to satisfactory performance and can be terminated by the Competent Authority of the Administration of UT Ladakh without assigning any reason what so ever at any time.

It is further ordered that in case the appointee fails to join within a period of 21 (twenty-one) days from the date of issuance of the appointment order, he shall forego his right to appointment, which shall be deemed to have been cancelled abinitio without any further notice.
