In Pursuance to the decision taken during 2<sup>nd</sup> meeting of Ladakh Pollution Control Committee, UT Ladakh regarding adoption of Uniform Consent Mechanism issued by CPCB, vide no. B-29012/ESS(CPA)/2015-16, Dated: 07-03-2016, the validity period of consent issued under section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 and /or section 21 of the Air (Prevention and Control of Pollution) Act, 1981 shall be as follows with effect from 1<sup>st</sup> February 2023.

RED	01 Year	05 Years
ORANGE	-do-	10 Years
GREEN	-do-	15 Years

Provided that the occupier shall have to deposit the annual Consent fees for the entire period of five, ten and fifteen years, as the case may be, while applying for Consent to Operate otherwise the period of validity of the Consent shall be as worked out on the basis of the fees deposited in multiples of one year.
