Subject: Expression of Interest (EOI) for finalization of Holograms Specifications.

Excise Department, Union territory of Ladakh is going to re-execute the process of e-tendering for production and supply of Polyester based security Holograms. It is hereby informed to all the interested tenderers, who manufactures and supplies polyester based security Holograms to submit their latest technical specification (security features) along with digital presentation at the conference hall of Deputy Commissioner, Leh on 18-03-2023 at 11:00 AM, so that the same can be included in Tender Documents.

It is not mandatory that the technical specifications given by different tenderer shall be included in Tender Document for production and supply of polyester based security Holograms. It is the discretion of Excise Commissioner, Union territory of Ladakh only. The approximate volume of holograms that would be required for 1 year would be approximate 90 lacs in numbers.

Only those tenderers will participate who fulfil the following conditions:

- 1. The tenderer should have licensed manufacturing facility including the Master origination facility in India, all in one premises. In case a tenderer has collaboration with any international manufacturer for Master Origination facility, such Mastering Facility should be located in India in one premise.
- 2. The tenderer should have an annual turnover of not less than Rs 50 lacs per annum during the preceding two years (FY 2020-21 & FY 2021-22), in the manufacture and supply of polyester based Security Holograms only and not other products like holographic films (wide web etc.), polyester film, paper label, paper label with hologram, etc.
- 3. The tenderer should have minimum "Net worth" of Rs. 1 Crore as on 31st Mar, 2022.
- 4. The tenderer should have at least 03 (three) years of experience in the field of manufacture of security Holograms as well as operating a mastering lab and should be presently capable to produce polyester based Security Holograms with upto 1,20,000 DPI (with Litho).
- 5. The tenderer must have experience in supplying Excise holograms to any State Excise Department only in India in any one of the last 3 financial years 2019-20, 2020-21 & 2021-22 for affixation on liquor bottles. The holograms must have been manufactured completely in-house in one premises.

- 6. The tenderer should have Hologram Master Origination facility of upto 1,20,000 DPI with Litho. In addition to these master origination systems, the tenderer must have complete in-house facilities viz. Art work creation, Master Origination, Glass negative preparation, developing of glass Master, Nickeling process, Metal Master preparation, Embossing, Lamination, Diecutting, Coating, inkjet and Invisible UV numbering etc. In case a tenderer has collaboration with any international manufacturer for Master origination there should be an agreement with the manufacturer and such facility should be located within the bidder's premises.
- 7. Any trader, dealer, person, firm, company, unit or their directors, Promoters, Owners, senior executives, their relatives and associate company/units etc. having any interest in the liquor and alcohol business or having licenses to deal in above related business within the State or any other State at any point of time now or in the past, shall not be eligible to participate in this tender.
- 8. The tenderer must be a member of both International Hologram Manufactures Association and ASPA (Authentication Solution Providers Association-formerly known as Hologram manufacturer association of India) for the last 03 years.
- 9. The tenderer and/or their associates or any of its Directors, Promoters, Owners, or Key Managerial person (KMP) or Principal Officer and other senior functionaries should not have been apprehended and/or convicted for any criminal activity by any Court of law in India in a case of corruption or any other criminal activity at any point of time after tenderer organization's coming into existence.
- 10. Tenderer should have ISO–9001:2015 Certification for their manufacturing facilities, and should possess the consent-letter as well as Authorization for Hazardous waste from the concerned State Pollution Control Board.
- 11. Tenderer must have HSSMS (Hologram Safety and Security Management System) certificate.
