Expression of interest for empanelment of Agencies for supply, installation, testing & commissioning of grid connected Rooftop solar PV Power Plants in residential premises of UT of Ladakh including Five (05) years comprehensive maintenance contract (CMC) under Grid connected Rooftop Solar Scheme Phase-II of MNRE, GOI.

Notification no: 102 9 2023 **Date: 20th, March, 2023**

This is in continuation to the Minister of New and Renewable Energy, GOI office memorandum vide letters dated; 02, February, 2022 and 10, June, 2022 through which procedure for installation of residential grid connected **Rooftop solar plants** was conveyed.

As such Ladakh Power Development Department, invite Expression of Interest for empanelment of agencies for supply, installation, testing and commissioning of grid connected rooftop solar PV Power Plants in residential premises of UT of Ladakh including Five (05) years comprehensive maintenance contract (CMC) under Grid connected Rooftop Solar Scheme Phase-II of MNRE, GOI as applicable. The agencies shall have minimum qualification criteria as specified by MNRE under Grid connected Rooftop Solar Scheme Phase-II and agencies shall not be backlisted anywhere in India by any State Govt;/Central Govt;/PSUs.

The agencies shall execute the work that is supply, installation, testing and commissioning of grid connected rooftop solar PV Power Plants in residential premises of UT of Ladakh including Five (05) years comprehensive maintenance contract (CMC) strictly as per technical standards, specifications, terms & conditions and guidelines issued by the MNRE Govt; of India from time to time in regard to grid connected Rooftop Solar PV Power Plants under Phase-II.

In this regard for empanelment/register of vendors, the interested agencies fulfilling the qualifications criteria can submit the application along with declaration (as per Annexures issued by MNRE) and deposit a PBG of 2,50,000/- (Rupees Two Lakh Fifty Thousand only) valid for at least five years in the Office of Chief Engineer Generation Wing, UT Ladakh Choglamsar Leh/Office of the Executive Engineer, Electric Project Division, Leh/Kargil during working hours. The name of the qualified vendor will be included in the list of registered/empaneled vendors at www.solarrooftop.gov.in in which will be valid initially for one year from the date of empanelment and may be renewed thereafter on yearly basis. The application received without the requisite documents would be rejected.

The application submission date is as under: -

Start date of submission of Application= 25th, March, 2023

Date of Vender list update = Monday, Last week of every month, incase there is holiday the same will be updated on next working day.


The registered /empaneled vendor selected by the beneficiaries will conduct the physical survey to assess the RTS capacity and guide the beneficiary on the RTS capacity that can be installed in the beneficiary's premises considering technical and financial parameters. The vendor shall also provide assistance to the beneficiary in getting necessary approvals, installing the net-meter and facilitating inspection by the DISCOM.

In case of any misleading information is provided by any vendor or conditions mentioned in the declaration are not met, the department will take action against the registered/empaneled vendor including black listing and forfeiture of PBG.



The subsidy available under the simplified procedure will be the same for beneficiaries all over the country. The rates of subsidy will be notified for each calendar year and will be applicable for all beneficiaries who have registered their application on the portal during the calendar year. Rooftop solar already installed will not be provided subsidy through this scheme/portal.
