#### Notification

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Government of India, Ministry of Home Affairs, New Delhi Notification No S.O. 5088(E) dated.1<sup>st</sup> November,2022, and in supersession of all earlier notifications on the subject matter, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of **Tourist Officer** in the Ladakh Tourism Department, namely:

#### 1. Short title and commencement. -

- (i)These rules may be called the Ladakh Administration, **Tourist Officer** in Ladakh Tourism Department "Group B Gazetted Post" Recruitment Rules, 2023.
- (ii) These rules shall come into force from the date of their publication in the Official Gazette.
- 2. Number of posts, classification, and Level in the Pay Matrix. -The number of said posts, its classification and Level in the Pay Matrix attached thereto shall be as specified in column (2), (3) & (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age limit, other qualifications. -The method of recruitment to the said post, age limit, qualifications and other matters relating to said posts shall be as specified in columns (5) to (13) of the Schedule annexed hereto.

#### 4. Disqualification. -

No person,

(a) shall be qualified for appointment to the said post unless the person is a Resident of Union Territory of Ladakh and must possess a Resident Certificate issued by a Competent Authority in accordance with the Union territory of Ladakh, Grant of Resident Certificate (Procedure) Order, 2021;

Provided that, this disqualification shall not apply in any case where a special procedure is established under any applicable law;

Provided further that the **Lieutenant Governor** (Administrator), by order, may in interest of administration waive the application of this disqualification for appointment to a specific post(s)

b. who has entered into or contracted a marriage with a person having spouse living;

OR

c. who having a spouse living, has entered into or contracted a marriage with any person(s) shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor (Administrator) of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

#### 5. Power to relax. -

Where the Lieutenant Governor (Administrator) is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings. -

Nothing in these rules shall affect reservations, relaxation in age-limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, and the other special categories of persons in accordance with the instructions or orders issued by the Administration of Union territory of Ladakh or by the Central Government from time to time in this regard.
