2.	Chief Engineer, PW(R&B).	Member
3.	Executive Engineer, CPWD.	Member
4.	Accounts Officer, PW(R&B) Department.	Member

The Committee may co-op any other member, as and when required for ensuring quality monitoring of the UT projects/works undertaken by BRO.

Terms of reference:

The terms of reference of the Monitoring Committee shall be as under:

- 1. To monitor and inspect projects/works of the UT executed through BRO for ensuring execution of the works by BRO as per prescribed specification and quality standards as envisaged in the MoU and Manual for Procurement of Works- 2022.
- To Assess the actual progress made by the executing agency and quality of the works maintained and report issues/impediments, if any observed to UT Administration and BRO for suitable solution and course correction.
- 3. To hold a review meeting every four months as may require, with the BRO authorities for resolving issues, if any, concerning the smooth execution of projects/works and timely completion of works/projects by BRO as per mutually agreed time-schedule/ milestones and within agreed Cost. The expenditure on monitoring etc shall be kept to the minimum.

- 4. To submit report of its findings and observations during the inspection and motoring of works/projects executed by BRO to the UT Administration with recommendation of improvements in quality standard of the works.
- 5. To advise the Administration of the UT and the concerned Department on devising any other quality control mechanism for ensuring the quality control of the UT works/projects executed through BRO.
- 6. To advice the Administration of the UT and the concerned Department for putting a system in place to facilitate removal of the impediments, if any, faced by Department and BRO in the project execution cycle and set a definite time period within which all the approvals/clearances are accorded to the project(s).

The UT level Monitoring Committee shall be serviced by the Public Works (R&B) Department.
