The functions of the Immediate Emergency Assistance Committee /Terms of reference are as follows: -

- 1. The Committee shall be responsible and competent for taking effective remedial measures for tackling any untoward crisis of any kind that may arise in the Union territory of Ladakh.
- 2. To provide expert guidance to the UT Administration for handling major crisis situations and suggest measures for prevention and mitigation of the risks associated with the crisis.

- 3. To devise holistic Contingency action plans, interventions, Standard Operating Procedures/guidelines for the management of different types of crises.
- 4. To examine the adequacy of existing resources/measures and synchronize the activities of different departments and agencies and appropriate authorities in the Government of India involved in the management of the crisis.
- 5. The Committee shall be responsible <u>for assessing and continuous</u> <u>monitoring</u> all kinds of crisis situations for prevention of the recurrence of such emergencies in the Union territory.
- 6. The Committee shall meet fortnightly under the chairmanship of Advisor and as soon as possible after receipt of information from reliable sources of any emergency situation/crisis in the Union territory.
