### NOTICE-I

WHEREAS, no Hotel or Restaurant or Banquet Hall can be setup or run without the Consent to Establish/Operate, of the Pollution Control Committee as envisaged under Section 25/26, and Section 21 of the Water (Prevention and Control of Pollution) Act, 1974, and the Air (Prevention and Control of Pollution) Act, 1981, respectively.

WHEREAS, no hotel with 20 bedrooms, and above, and Restaurants/ Banquet Halls, with minimum seating capacity of 36 and above, can be Establish/Operate, without installation of Sewage Treatment Plant (STP), and Effluent Treatment Plant (ETP), respectively, as per the Environmental (Protection) Rules, 1986, as amended from time to time.

WHEREAS, no hotel with less than 20 bedrooms, or Restaurants with less than seating capacity of 36, can be Establish/Operate without well maintained septic tank, and no effluent shall be discharged into the municipal sewer without Oil and Grease trap.

WHEREAS, your unit is not strictly adhering to the conditions as imposed by Environment (Protection) Act, and Rules, framed there under, beside not taking prescribed measures, and efforts for installation of Pollution Control Devices, to keep the levels of pollution/emissions within the prescribed permissible limits as per Air (Prevention and Control of Pollution) Act, 1981, Water (Prevention and Control of Pollution) Act, 1974, and amendments thereafter.

THEREFORE, in view of above, and in exercise of powers vested under section 5 of Environment (Protection) Act, 1986, you are hereby directed to Show Cause as to why the penal action should not be initiated against you, **including levying of Environmental Compensation and closure of your unit**, for non-compliance of Environmental norms. The reply to this notice should reach the undersigned within 7 days from the date of issue of this notice.
