**Subject: - Un-authorized absence of Sh. Sumeet Kumar Puri, Chief Engineer, PHE/I&FC from duty- Relieving of the Officer thereof.**

**Order No.173-LA (GAD) of 2023,  
Dated: -02.06.2023.**

**WHEREAS**, in terms of Govt. Order No.201-JK(JSD) of 2022 dated: - 17.09.2022, Er. Sumeet Kumar Puri, I/c Chief Engineer, was deputed to Ladakh by the Jal Shakti Department, UT of J&K;

**WHEREAS**, on his joining in the UT of Ladakh, Sh. Sumeet Kumar Puri, I/c Chief Engineer was placed at the disposal of PHE/I&FC Department, Ladakh vide this Department's Order No.283-LA(GAD) of 2022 dated:-28.09.2022 and the Officer was subsequently posted as Chief Engineer, PHE/I&FC by the PHE/I&FC Department, Ladakh vide Order No.34-LA(PHE/I&FC) of 2022 dated: -29.09.2022;

**WHEREAS**, the Officer had left the station/headquarter un-authorizedly on 21.10.2022 and went to Jammu and remained un-authorized absence from 21.10.2022 to 25.10.2022 by submitting a leave application, without prior sanction and station leaving permission from the competent authority;

**WHEREAS**, decisions on his un-authorized leaving of the head quarter and un-authorized absence from 21.10.2022 to 25.10.2022 were pending in the PHE/I&FC Department, the Officer had again left the station on 28.11.2022 un-authorizedly for Jammu by submitting a leave application and without taking prior sanction of leave and permission to leave the station and remained absent till 09.12.2022;

**WHEREAS**, decisions on his un-authorized leaving of headquarter and un-authorized absences from duties w.e.f 21.10.2022 to 25.10.2022 and w.e.f from 28.11.2022 to 09.12.2022 were pending, the Officer again submitted a medical leave vide application dated: - 22.12.2022 which was not considered by the competent authority and he continued to remain absence from duties till date;

**WHEREAS**, vide letter No. M/1292/2022-(PHE, InFC) SECTION dated: - 20.01.2023, followed by reminder letter dated: - 13.04.2023, the UT of J&K was informed of the continuous absence from duties of Sh. Sumeet Kumar Puri, I/ Chief Engineer and was requested to initiate disciplinary proceedings against the said Officer under J&K Civil Services (Classification, Control & Appeal) Rules,1956;

**WHEREAS**, the continuous un-authorized absence from duties of Sh. Sumeet Kumar Puri, I/c Chief Engineer for more than five months since 22.12.2022 has affected the functioning of the Department badly and the Officer did not join back for duties, till date;

**WHEREAS**, due to his continuous absence from duties, vide Order No.09-LA-(PHE/I&FC) of 2023 dated: -20.02.2023, the salary of the Sh. Sumeet Kumar Puri, I/c Chief Engineer was kept withhold from the month of Febraury,2023 in terms of provisions under FR-17, till Government of J&K takes a decision on his un-authorized absence from duties;

**WHEREAS**, Sh. Sumeet Kumar Puri, I/c Chief Engineer filed a petition in the Hon'ble Central Administrative Tribunal in Original Application No.62/255/2023 against the Order dated;-20.02.2023 and has made a prayer before the Hon'ble CAT for his transfer from Ladakh;

**WHEREAS**, the Hon'ble CAT disposed of the Original Application with the direction to respondent No.2 (UT of J&K) to decide the applicant's representation dated: -14.11 2022 and revisit the order of his deputation dated: -17.09.2022 to Ladakh; and

**WHEREAS**, the decision on the representation dated:-14.11.2022 of Sh. Sumeet Kumar Puri, I/c Chief Engineer lies with J&K Government which is also the disciplinary authority to decide his period of absence;

**NOW THEREFORE**, considering no decision on this Department's recommendation vide letter No. M/1292/2022-(PHE,InFC) SECTION dated: - 20.01.2023 has been conveyed so far by the J&K Government and continuous absence of Sh. Sumeet Kumar Puri is affecting the work in UT of Ladakh, thus in compliance of the direction of the Hon'ble CAT and in the interest of Administration, Sh. Sumeet Kumar Puri, I/c Chief Engineer is hereby relieved of from duties in the UT of Ladakh with immediate effect with the direction to report to the General Administration Department, UT of J&K for further directions.

Further, the LPC and drawl statement of the Officer from his joining in Ladakh till date are hereby attached as **Annexure-A & B** to this Order for further necessary action.


