Subject- Timely disbursement of pension to eligible and registered beneficiaries of National Social Assistance programme (NSAP) and Integrated Social Security Scheme (ISSS).

Social and Tribal Welfare Department has been implementing various welfare schemes including Pension schemes. The Department is implementing two major Pension Schemes viz.

(1) National Social Assistance Programme (NSAP)-

**- any event of death (natural or otherwise) would make the family eligible for assistance. A woman in the family, who is a home maker, is also considered as a 'bread-winner' for this purpose. The death of such a bread- winner should have occurred whilst he/ she is more than 18 years of age and less than 60 years of age.

| S.No | Sub components | Amount of pension per month | Eligibility |
|------|--|-----------------------------------|---|
| 1 | Old age pension | Rs 1000 | (BPL) Persons of 60 Years (Men) and 55 years (Women) and above |
| 2 | Pension for Women in Distress | Rs 1000 | (BPL) Women in distress, including destitute, separated, divorced or widow are provided financial support in the form of monthly pension The applicant should be aged between 40-79 years |
| 3 | Pension to Physically challenged persons | Rs 1000 | The pension is provided to persons with 40% or more disability and having no source of income. Physically Challenged Person should be in the age of 18-79 years. |

(2) Integrated Social Security Scheme (ISSS)

2. To facilitate the pensioners, lead an easier and dignified life, the Department of Social and Tribal Welfare has designed an internal mechanism to ensure timely disbursement of pension and accordingly the following timelines have been laid down for each activity:

- i. Verification of Beneficiaries District Social Welfare officer shall verify and submit data of the beneficiaries to the Directorate by 21st of each month.
- ii. **Processing of Beneficiary Details** Directorate shall process and submit the beneficiaries' details to the District Treasury, Kargil by 25th of every month.
- iii. Release by the District Treasury District Treasury, Kargil shall complete the payment to the agency account of Directorate of Social Welfare within 7-10 days after submission of beneficiaries' details by Directorate to the Treasury, i.e. by 5th of every month for pension of preceding month. (As decided in consultation with District Treasury officer/Pay and Account Officer, Kargil)
- iv. **Payment to beneficiaries** Payment to beneficiaries shall be released by the Directorate within 03 working days of release by the Treasury, i.e. by 8th of every month for pension of preceding month.

These timelines given are the maximum time taken to process each activity at different level and there shall be no delay beyond timelines given above.

In case, pension (Full amount in case of ISSS and UT share in case of NSAP) is not received by 8th of every month, beneficiaries are requested to raise a complaint either via e mail on <u>directorsocialwelfareladakh@gmail.com</u> or physically at the following <u>address-</u>
