In pursuance of Section 4(I) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, sanction is hereby accorded to the constitution of the Complaint Committee, comprising the following, to register and enquire into and dispose of the complaints, if any, of sexual harassment against women employees of the Civil Secretariat:-

1	Ms. Tashi Dolma, KAS, Additional Secretary, Home Department.	Chairperson
2	Mr. Mohd Taqi, Under Secretary	Member
3	Ms. Gulnaz Goni, Law Officer, GAD	Member
4	Representative of a NGO to be nominated by the Social Welfare Department.	Member
5	Any other person co-opted by the Chairperson.	Member

The committee shall submit to the Government in General Administration Department:

- i. Its report on each complaint received by it regarding sexual harassment against women employee(s) of the Secretariat for consideration of the Administration; and.
- ii. Quarterly/ annual reports about the total number of complaints received, enquired into by the Committee and action taken on the same.

The Committee shall meet as often as may be required.

It is further ordered that:-

- i. All the Administrative Secretaries shall constitute similar committees in their respective departments at the UT/Division and District levels as the case may be;
- ii. These committees shall address all complaints of sexual harassment and submit action taken reports to the Administration with specific recommendations, in accordance with rules, on quarterly/annual basis; and

- iii. The constitution/composition of the committees shall be reviewed periodically by the General Administration Department/ Administrative Department to include/ exclude the members as a consequence of retirement, transfer, etc.


