In terms of para-9 of the guidelines of Department of Expenditure vide O.M No.24(35)/PF-II/2012 dated: -05.08.2016, sanction is hereby accorded to the constitution of a 'Revised Cost Estimation Committee' in the Union territory, comprising the following for examining the revised cost estimates exceeding 20% of the original approved cost of project(s) of Departments under SDP/State Capex budget, before placing for fresh appraisal and approval before the competent authority:

**Terms of reference of the Committee shall be as under:**

1. To examine the cases of revised cost estimates exceeding 20% of the original approved cost of project(s) placed before the committee by Department(s) as per guidelines of the Department of Expenditure as mentioned above.
2. To identify the specific reason behind such increase, identify lapses, if any and suggest remedial measures for the same.
3. The Committee may call the concerned SE & Executive Engineer to provide justification of each case and accordingly recommend the case(s) of revised estimates exceeding 20% of the original approved cost of project(s) for placing before the competent

authority for appraisal, accepting and approving the cost revision on case-to-case basis.

The Committee shall be serviced by the concerned Department as the case may be.
