Mandate of the committee.

The committee shall;

- a) submit its report on each complaint, received on sexual harassment against women employee (s) of Directorate of School Education, Ladakh.
- b) shall submit report about the total no of complaints received and action taken report on each to the Administrative Department.
- c) the committee shall also submit status report on quarterly/annually and provide related information as and when required.
- d) the term of office shall be a maximum of three years from the date of their nomination.
- e) any member or the Chairman of the internal committee shall be removed from the committee if, he/she;
 - i. contravenes the provisions of section 16; or

- ii. has been convicted for an office or an inquiry into an offence under any law for the time being/in force is pending against him/her; or
- iii. has been found guilty in any disciplinary proceedings is pending against him/her; or
- iv. has so abused his position as to render his continuance in office prejudicial to the public interest.
- f) The vacancy, if created by any means, or any casual vacancy shall be filled by fresh nominations in accordance with the provisions of the relevant section of the rules.
