Subject: -Fixation of water usage charges.

Order No. 31-LA(PHE/I&FC) of 2023, Dated: -08.08.2023.

Whereas, in terms of section 128 and section 145(2) of the J&K Water Resources (Regulation & Management) Act,2010, water usage charges had been fixed by the J&K Water Resources Regulatory Authority of the erstwhile State of J&K from time to time;

Whereas, the said authority vide Order No.46/SWRRA of 2018 dated: -28.06.2018 had fixed the water usage charges in respect of different categories of usage of water, which were applicable to Ladakh prior to formation of Union territory;

Whereas, on implementation of the Jal Jeevan Mission and coverage of functional household tap connections individual households, the water usage charge is required to be revised and fixed for providing sustained water supply to the households in rural areas;

Now, therefore, in exercise of powers conferred under section 128 and section 145(2) read with proviso to Sub-section (1) of Section 139 of the Jammu & Kashmir Water Resources (Regulation & Management) Act, 2010, the State Water Resources Regulatory Authority Ladakh, hereby fix the water usage charges for unmetered connection provided under JJal Jeevan Mission for drinking purposes in rural areas to rural households and public institutions, as per **Annexure-I** to this order, till further orders.

The water usage charge in Urban areas and in respect of other categories of usage (other than drinking purposes) shall continue to be charged on the same rate as
