3. Recommendations/Decisions of the Departmental Promotion Committee: -

- a) In relation to the officials mentioned in paragraph II, the committee recommended their Time-Bound Promotion (in-situ) from the respective eligible dates as indicated in column No. 6. The issuance of Time-Bound Promotion (TBP) will be subject to the receipt of Vigilance Clearance Certificates for each case from the Chief Vigilance Officer, UT-Ladakh.
- b) Concerning the officials outlined in paragraph III (from Serial No. 1st to 20th), the committee recommended their confirmation for the next higher posts. This confirmation shall take effect from the date of the Departmental Promotion Committee (DPC) Meeting held on 08.08.2023 and in some cases it was unanimously decided by the Departmental Committee members to give them retrospective effect for the benefits of all the employees of the Agriculture Department, UT-Ladakh. However, due to the pending Vigilance Clearance Certificates in many cases, the Issuance of Promotion/Time-Bound Promotion orders will be contingent upon receiving the Vigilance Certificate from the Chief Vigilance Officer, Ladakh.

Furthermore, prior to the issuance of orders conferring benefits to all employees mentioned in paragraphs II and III, as permitted by the rules, the respective Drawing and Disbursing Officers (DDOs) under the oversight of the Head of Department (HoD) shall reverify their pay levels and the effective dates for implementing these changes. This verification should align with the details present in the service books/records, and the employees' pay should be adjusted accordingly.
