This is in continuation to Order No. 42 S&TW/2023, Dated 31.07.2023 and Order No. 10-DSWO OF 2023, dated 17.07.2023 regarding appointment of staff on temporary basis under Mission Vatsalya, Mission Shakti and Mission Poshan 2.0. The selected candidates were directed to join at the Office of the Commissioner/Secretary alongwith the requisite documents within a period of 15 days. As per the aforesaid order, in case any candidate fails to join within prescribed period, without any justifiable reason, the engagement order shall be treated to have been cancelled ab-initio in respect of such candidates(s).

In view of failure of some of the candidates to join, candidates as given at Annexure "A" who were in the waiting list against the corresponding contractual posts are selected and further directed to report to the office of Commissioner Secretary, Social & Tribal Welfare Department, UT Secretariat Leh, along with supporting documents for physical verification within a period of 03 working days from the issue of this order.

Further, vide order No. 10-DSWO OF 2023, Dated: 17.07.2023 one candidate selected as Call Operator under Mission Shakti had submitted inability to continue in the office for two months due to health issue. Since there is no provision of grant of medical leave as per the guidelines issued by the Ministry, one post of call operator has fallen vacant and accordingly candidate in the waiting list is hereby selected for the same post as mentioned in Annexure.
