In pursuance to the above-mentioned advertisement notice dated 31.08.2023 and as per the recommendation of the UT Level Selection Committee for the selection of Consultant Health and Nutrition under Mission Poshan 2.0, sanction is hereby accorded to the temporary appointment of candidate as mentioned below for the post of Consultant Health and Nutrition under Mission Poshan 2.0 upto Financial Year 2025-26 subject to Annual Performance Appraisal.

The candidate engaged shall report to the office of Commissioner Secretary, Social & Tribal Welfare Department, UT Secretariat Leh, UT of Ladakh, along with the requisite documents. The engagement shall be subject to the following conditions:

Terms & Conditions:

1. The appointment is purely on contractual basis and continuous/renewal of contract shall not confer any right of claiming regularization/permanent absorption against the post.
2. The appointment upto FY 2025-26 shall be subject to annual performance appraisal being satisfactory and clearance from vigilance angle.
3. The candidates shall execute an agreement through a prescribed affidavit duly executed/sworn before learned Judicial Magistrate to the effect that he/she will have no claim any right for any sort of permanent absorption/regularization in the Administration at any later stage.
4. Director Social & Tribal Welfare Department, UT of Ladakh shall get the character antecedents of the appointees verified from the competent authority and in the event this office receives any adverse report with respect to the character antecedents or documents/certificates furnished produced by the candidate, the engagement order shall be treated to have been cancelled ab initio and criminal proceedings shall be initiated against candidate.

5. The staff shall be eligible for 12 days leave in a calendar year, thereafter remuneration would be deducted on pre-data basis.
6. The appointee shall join within a period of 07 days from the date of issue of this order. In case of any candidate fails to join within the prescribed period, without any justifiable reason, that is accepted by the Department, the engagement order shall be treated to have been cancelled ab-initio in respect of such candidate and the waitlist shall be initiated.
7. The contractual appointment shall be valid for said period or as may be extended by the MoWCD. After joining the duties, the appointee has to serve notice of 30 days minimum or will pay gross salary (inclusive of all allowances) of the equivalent period in lieu of the notice in case he/she decide to leave the job. Notwithstanding this, in the event of work for which he/she is being employed comes to an end before the aforementioned period, this contractual employment shall be co-terminus with aforementioned work.
8. At the end of the above referred period, the contractual appointment will stand terminated automatically without any notice or communication, unless they are explicitly extended by the issuing authority by a letter in writing.
9. The candidates shall be allowed to join on production of the following certificates (in original)
 - i. Qualification Certificate viz. Degree/Marks.
 - ii. Age Certificate
 - iii. Certificate from the concerned authority to the authority to the effect that no loan under self-employment scheme has been taken by the concerned.

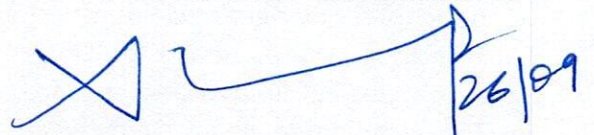
