#### Notification

Ladakh, the October, 2023

......In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Govt. of India, Ministry of Home Affairs, New Delhi Notification No. S.O 5088(E) dated 1st November, 2022 and in supersession of all earlier notifications on the subject matter, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following recruitment rules for regulating the method of recruitment to the post of the, Joint Director Economics & Statistics in the Ladakh Economics & Statistics (Gazetted) Recruitment Rules of the Planning Development & Monitoring Department, namely: -

- Short title and commencement: -1.
- i. These rules may be called 'The Ladakh Economics & Statistics (Joint Director Economics & Statistics) (Gazetted) Recruitment Rules, 2023 of the Planning Development & Monitoring Department.
- ii. These rules shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and Level in the Pay Matrix:-2.
  - The number of said posts, its classification and Level in the Pay Matrix attached thereto shall be as specified in paras 2, 3 & 4 of the Schedule annexed hereto.
- Method of recruitment, age limit, qualifications: -3.

The method of recruitment, age limit, qualifications and other matters relating to said posts shall be as specified in paras 5 to 13 of the Schedule annexed hereto.

Provision for Resident Criteria for appointment by direct recruitment: -4. The eligibility for appointment will be subject to residency requirements prescribed in any Act, Rule, Regulation or Order in force in the Union territory of Ladakh.

#### **Disqualification:** -5.

No person,

a. who has entered into or contracted a marriage with a person having a spouse living;

b. who, having a spouse living, has entered into or contracted a marriage with any person(s) shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor (Administrator) of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

#### 6. Power to relax: -

Where the Lieutenant Governor (Administrator) is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

7. Savings: -

Nothing in these rules shall affect reservations, relaxation in age limit, and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, and other special categories in accordance with the Rules, Instructions or Orders issued by the Administration of Union territory of Ladakh.

- With 05 years of regular service in the level-11 in the pay matrix or equivalent in the parent cadre/department.
- b. Possessing the educational qualifications of Masters' Degree in Economics or Mathematics or Commerce (with compulsory to have one of the subjects in these 03 degrees as Statistics) or Masters' Degree in Statistics from a recognized University or Institute.

Note 1: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists
