
Consequent upon the selection made by the Staff Selection Commission (on behalf of the Administration of Union territory of Ladakh) and with approval of the Competent Authority / Appointing Authority, you are hereby offered provisional appointment to the post of JUNIOR LIBRARIAN (Group 'C' Non-Technical), in Culture Department of the Administration of Union Territory of Ladakh in Level 4 of Pay Matrix (Rs. 25500 -81100) on the following terms and conditions:

- (1) In addition to basic pay in Level 4 of Pay Matrix (Rs. 25500-81100), you will be entitled to draw dearness and other allowances at the rates admissible and subject to the condition laid down in Rules/Orders governing grant of such allowances.
- (2) You will be on probation for a period of two years from the date of joining the post. The period, of probation may, however, be extended at the discretion of the Competent Authority / Appointing Authority. As regards other matters relating to probation, the same shall be governed by the conditions prescribed under the Ladakh Libraries (Subordinate) Service Recruitment Rules, 2021 and other Rules and instructions issued in this regard by the Central Government / Administration of the UT of Ladakh.
- (3) The appointment carries with it the liability to serve anywhere within the territorial/administrative jurisdiction of the Union territory of Ladakh.
