NOTIFICATION

Ladakh, the____October ,2023

.----- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Govt. of India, Ministry of Home Affairs, New Delhi Notification No. S.O 5088(E) dated 1st November,2022 and in supersession of all earlier notifications on the subject matter, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of **Assistant Director** in the Ladakh Technical Education & Skill Development Department (ITI Sector), namely:

1. Short title and commencement: -

- (a) These rules may be called the Ladakh Administration, **Assistant Director** in Ladakh Technical Education & Skill Development Department Rules, 2023.
- (b) These rules shall come into force from the date of their publication in the official Gazette.

2. Number of posts, classification and Level in the Pay Matrix: -

The number of said posts, its classification and Level in the Pay Matrix attached thereto shall be as specified in paras 2,3 & 4 of the Schedule annexed hereto.

3. Method of recruitment, age limit, other qualifications: -

The method of recruitment, age limit, qualifications, and other matters relating to said posts shall be as specified in paras 5 to 13 of the Schedule annexed hereto.

4. Provision for Resident Criteria for appointment by direct recruitment: -

The eligibility for appointment will be subject to residency requirement prescribed in any Act, Rule, Regulation or Order in force in the Union territory of Ladakh.

5. Disqualification: -

No person,

a. Who has entered into or contracted a marriage with a person having spouse living;

OR

(b) Who having a spouse living, has entered into or contracted a marriage with any person



(s) shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor (Administrator) of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

6. Power to relax: -

Where the Lieutenant Governor (Administrator) is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

7. Savings: -

Nothing in these rules shall affect reservations, relaxation in age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, and the other special category of persons in accordance with the instructions or orders issued by the Administration of Union Territory of Ladakh.

Note 2: Where juniors who have completed their qualifying/ eligibility services are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/ eligibility service by more than half of such qualifying/ eligibility services, or two years, whichever is less, and have successfully completed their probation to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

Deputation (Including Short Term Conttract):-

Officers under Central Government/ State Governments/ Union Territory Administrations/Public Sector Undertakings/ Universities/ Recognized Institutes/ Recognized research institutions/ Autonomous Organization/ Statutory Organization:

- (a) (i) Holding analogous post on a regular basis in the parent cadre/department; or
- (ii) With 02 years of regular service in post in the Level-9 in the pay matrix or equivalent in the parent cadre/ department;
- (iii) With 06 years of regular service in post in the Level-8 in the pay matrix or equivalent in the parent cadre/department; and
- b) Possessing the following educational qualifications and experience:
- i. Bachelor Degree in Engineering (Bachelor of Engineering/Bachelor of Technology) from a recognised University/Institute.
- ii. Three years of experience in a supervisory capacity or administrative or teaching.

Note: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note: Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cade post held immediately preceding this appointment in the same or other organization/department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment under deputation (ISTC) shall not be exceeding 56 years as on the closing date of
