Whereas, after careful examination of the objection raised against the tentative seniority list of the Head Assistant, the Director, Social & Tribal Welfare Dept. had issued Order No. No: 72DSW of 2023, dated:18.10.2023 whereby one previous promotion of a Head Assistant issued vide Order No. 34/DPO/ICDS of 2017 dated: 29.11.2017 was cancelled/ withdrawn ab-initio.






