 - ii. he / she is otherwise found ineligible or unsuitable to be retained in the service.

This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / mark-sheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Revenue (Subordinate) Service Recruitment Rules, 2021.
- 4. The services of the above candidates appointed as Orderly is placed at the disposal of the Deputy Commissioner/ CEO, LAHDC, Leh for further deployment in the Subordinate Offices of the Revenue Department, Leh.
