The appointment shall be subject to the following conditions;

- 1. The appointees shall be on probation for a period of two years with effect from the date of their joining to the post. During the period of probation, the appointee(s) will be liable to be discharged from service at any time without any notice, if:
  - a) On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or
  - b) He / she is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Accounts (Subordinate) Services Recruitment Rule, 2021.
- 4. The appointees shall report to the Office of Director Accounts & Treasuries, UT Ladakh for joining within a period of one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
