The appointment shall be subject to the following conditions;

- 1. The appointee shall be on probation for a period of two years with effect from the date he joins the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of his performance or conduct, he is considered unsuitable for further retention in service, or
 - *b)* He is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointee has been declared medically fit by the Prescribed Medical Authority.

This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.
