  - They are otherwise found ineligible or unsuitable to be retained in the service. b)
- 2. The above appointee(s) has been declared medically fit by the Prescribed Medical Authority.

This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.
