1. The appointee(s) shall be on probation for a period of two years with effect from the date they joins the post. During the period of probation, the appointee(s) will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of their performance or conduct, they are considered unsuitable for further retention in service, or
 - b) They are otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointee(s) has been declared medically fit by the Prescribed Medical Authority.

3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.

1. The services of the above candidate(s) appointed as Domestic Staff are placed at the disposal of the Chief Medical Officer, Leh for further deployment in the Sub-ordinate Offices of the Health and Medical Education Department, Leh.
