1. The appointee shall be on probation for a period of two years with effect from the date they join the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
  - a) On the basis of their performance or conduct, she is considered unsuitable for further retention in service, or
  - b) She is otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointee has been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential

requirements as prescribed under the Union Territory of Ladakh School Education Department (Subordinate) Service Recruitment Rules, 2021.

4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.

**It is further ordered that;**

1. The services of the above candidate appointed as Driver Grade-II is placed at the disposal of Chief Education Officer, Leh for further deployment.
2. The appointee shall report to the Office of Chief Education Officer, Leh for joining within a period of one (01) month, from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled ab-initio without any further notice.
3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with respective place of posting upon his deployment in the respective office.
