- The above appointees have been declared medically fit by the Prescribed Medical Authority.
- The appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Animal Husbandry (Subordinate) Service Recruitment Rules, 2022.

4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.

It is further ordered that;

1. The services of the above candidate appointed as Junior Assistant is placed at the disposal of the Director, Animal/Sheep Husbandry & Fisheries Department, UT of Ladakh, for further deployment in the Sub-ordinate Offices/Divisions of the Animal Husbandry Department, Leh.
