- 1. The above appointees shall be on probation for a period of two year with effect from the date of their joining the post. During the period of probation, the appointee(s) will be liable to be discharged from service at any time without any notice, if:
 - (a) on the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or
 - (b) he/she is otherwise found ineligible or unsuitable to be retained in the service
- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. The appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirements as prescribed in Ladakh Animal Husbandry (Subordinate) Service Recruitment Rules, 2022.
- 4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.

It is further ordered that;

- The services of the above candidates appointed as Orderly are placed at the disposal of the Director, Animal/Sheep Husbandry & Fisheries Department, UT of Ladakh, for further deployment in the sub-ordinate Offices/Divisions of the Animal Husbandry Department of UT Ladakh.
- 2. The appointees shall report to the office of Director, Animal/Sheep Husbandry & Fisheries Department, UT Ladakh, for joining within a period of one (01) month, from the date of issuance of this Order, failing which his /her appointment shall be deemed to have been cancelled ab-initio.
- 3. The expenditure towards their pay and allowances shall be debited against the head of "salaries" from the Budget Head associated with their respective place of posting upon their deployment in the Sub-ordinate Offices/Divisions of the Animal Husbandry Department, Leh.
