On the recommendation of the Leh Autonomous Hill Development – Subordinate Services Recruitment Board, against the Post of Phase – II (Matriculate & 10+2 Level) of Advertisement Notice No. 02 of 2022, dt: -30/11/2022 and with the approval of the Administrator (i.e., LT. Governor of the Union Territory of Ladakh) the below mentioned candidate is hereby appointed to the post of Wildlife Guard (Group 'C', Non- Gazetted), in the Department of Forest, Ecology and Environment of the Administration of Union Territory of Ladakh, in Level-2 of pay matrix (Rs. 19900-63200) and other allowances as admissible under the Rules, with immediate effect: -


The appointment shall be subject to the following conditions: -

- The above appointee shall be on probation for a period of two years with effect from the date of his joining the post. During the period of probation, the appointee shall be liable to be discharged from service at any time without any notice, if
 - On the basis of his performance or conduct, he is considered unsuitable for further retention in services, and/or
 - He is otherwise found ineligible or not suitable to be retained in the service.
- The above appointee has to be declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; certificate of reserved category, date of birth, certificates / marksheets relating to the qualification and such essential requirements as prescribed in the Leh Autonomous Hill Development – Subordinate Services Recruitment Board.
- Other terms and conditions will be governed by the relevant Central Service Rules and Orders issued from time to time.
- The *inter-se* seniority of the above appointee shall be worked out as per rules.
- The appointment of the above appointee shall be subject to the outcome of writ petition (s), if any, pending before any competent Court of law.

It is further ordered that:

- i. The services of the above appointee are placed at the disposal of the Chief Wildlife Warden, UT of Ladakh for further deployment in the sub-ordinate Offices / Divisions of the Department of Wildlife Protection.
- ii. The appointee shall report to the Chief Wildlife Warden, UT of Ladakh for joining within a period of one month, from the date of issuance of this order, failing which his appointment shall be cancelled *ab-intio* without further notice.
- iii. The expenditure towards his pay and allowances shall be debited against the head of Salaries from the Budget Head associated with his respective place of posting upon his deployment in the sub-ordinate offices of the Forest Department.
