  - (b) he/she is otherwise found ineligible or unsuitable to be retained in the service
- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. The appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirements as prescribed in Ladakh Sheep Husbandry (Subordinate) Service Recruitment Rules, 2021.



Other conditions of service will be governed by the relevant rules and orders in force from time to time.

  issuance of this Order, failing which his /her appointment shall be deemed to have been
  cancelled ab-initio.
- The expenditure towards their pay and allowances shall be debited against the head of "salaries" from the Budget Head associated with their respective place of posting upon their deployment in the Sub-ordinate Offices/Divisions of the Sheep Husbandry Department, Kargil.
