## Terms of Reference of the State Higher Education Council of Ladakh:

- a) Offer guidance and advice on formulation of policy for the comprehensive and holistic transformation of the Higher Education sector in tune with the National Education Policy (NEP), 2020;
- b) Provide advice on specific matters to the Government and to the Universities, research institutions and other centres of Higher Education in Ladakh for formulating and implementing policies;
- c) Advice on the course of reforms to rejuvenate the higher education sector and research:
- d) Evolve new concepts and programmes for creating an industry-ready work force in consonance with the latest requirements as well as rapidly changing technologies;
- e) Specify norms and mechanisms for transparent, efficient and accountable governance in universities and other higher educational institutions;
- f) Suggest improvements in curriculum and syllabi including advice on introduction of new courses in accordance with changing academic and industry requirements;
- g) Review periodically the Statutes, ordinances and regulations of the Universities of the UT and suggest appropriate changes for the realization of the objectives of NEP-2020;
- h) Advice on improvising the standards of examinations and suggest reforms;
- i) Devise mechanisms for social audit process and public feedback on performance and achievements; RIGZIN Paigling Spalgon RIGZIN RIGZIN Spalgon

- *j)* Assist in assessing the existing infrastructural facilities of institutions and recommend additional facilities wherever required;
- *k*) Facilitate coordination between Universities in the UT and other Universities of the country and abroad to promote innovation and research and quality upgradation;
- *I)* Help develop programmes for greater academic cooperation and interaction between University teachers and College teachers;
- *m*) Improve the overall quality of existing state higher educational institutions by ensuring their conformity to prescribed norms and standards and adoption of accreditation as a quality assurance framework;
- n) Usher in transformative reforms in the UT's higher education system by creating a facilitating institutional structure for planning and monitoring, promoting autonomy in State Universities and improving governance in institutions;
- o) Ensure governance, academic and examination (and evaluation) reforms in the Universities and Colleges and establish backward and forward linkages with the school education sector on one hand and employment market, on the other hand, to facilitate self-reliance;
- *p)* Become the guiding force for smooth implementation of PM-USHA in higher education institutions of Ladakh.
