In terms of section 24 of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013 and for its implementation, sanction is hereby accorded to the constitution of the District Level Vigilance Committee in the Union Territory with the composition as under:

12.	District-Level officers of Departments and agencies who, in the opinion of the District Magistrate, subject to general orders, if any, of the State Government, have a significant role to play in the implementation of this Act.	Member

Vigilance Committee constituted at district level shall meet at least once in every three (03) months and shall observe such rules of procedure in regard to the transaction of the business at its meeting as may be prescribed.

Functions of the Vigilance Committee.

- (a) To advise the District Magistrate on the action which needs to be taken to ensure that the provisions of this Act or of any rule made thereunder are properly implemented;
- (b) To oversee the economic and social rehabilitation of manual scavengers;
- (c) To co-ordinate the functions of all concerned agencies with a view to channelise adequate credit for the rehabilitation of manual scavengers;
- (d) To monitor the registration of offences under this Act and their investigation and prosecution.
