- 1. The appointee shall be on probation for a period of two years with effect from the date he / she joins the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of his performance or conduct, he is considered unsuitable for further retention in service, or
 - b) He is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointee has been declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union territory of Ladakh Rural Development Department (Subordinate) Service Recruitment Rules, 2021.
