Whereas, pursuant to the recommendations of the Leh Autonomous Hill Development, Subordinate Services Recruitment Board, among others, the candidates annexed as "A" were provisionally selected for the post of Class-IV in School Education Department UT Ladakh for district cadre Leh, in the pay level – SL1 of pay matrix (₹14800-47100) under various categories shown against each.

Whereas, School Education Department UT Ladakh vide Memorandum No. A/978/2023-EST SEC (GZ)-SED dated 18.10.2023 issued an offer of appointment to the candidates selected provisionally for the posts of Class-IV with the directions to submit the acceptance undertaking within 30 days from the issuance of memorandum.

Whereas, Chief Education Officer Leh has intimated that amongst (40) selected candidates (25) candidates shown in annexure "A" have failed to submit their acceptance undertaking within the stipulated time i.e. by 16.11.2023.

Whereas, in terms of instructions contained at para (15) in the Memorandum issued by the office of Administrative Secretary, School Education Department UT Ladakh, the candidates who fail to submit the undertaking within a period of 30 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Now therefore, in light of the above, the offer of appointment to the post of Class IV in School Education Department for district cadre Leh in respect of **the**

candidates shown in Annexure "A" is deemed to have been cancelled w.e.f. 18.11.2023.


