

The Executive Committee of the Ladakh Compensatory Afforestation Fund Management and Planning Authority (CAMPA) shall: -

- Formulate and submit annual plan of operations to the Steering Committee of the Ladakh Compensatory Afforestation Fund Management and Planning Authority (CAMPA) for its concurrence;
- Undertake qualitative and quantitative supervision, monitoring and evaluation of the works being implemented from amounts available in the Ladakh Compensatory Afforestation Fund;
- Invest surplus amounts available in the Ladakh Compensatory Afforestation Fund;
- Maintain books of account and other records;
- Submit reports to the Steering Committee of the Ladakh Compensatory Afforestation Fund Management and Planning Authority;
- Prepare annual report of the Ladakh Compensatory Afforestation Fund Management and Planning Authority;

- vii. Deploy staff on contractual basis or on deputation to the posts in the Ladakh Compensatory Afforestation Fund Management and Planning Authority;
- viii. Formulate proposals for creation of posts in the Ladakh Compensatory Afforestation Fund Management and Planning Authority;
- ix. Be responsible for delegation of financial or administrative powers;
- x. Be responsible other day to day working in respect of the Ladakh Compensatory Afforestation Fund Management and Planning Authority;
- xi. Maintain and update public information system on the Ladakh Compensatory Afforestation Fund Management and Planning Authority and present all information on its transition in the public domain;
- xii. Undertake any other works as may be assigned by Governing body or Steering Committee of the Ladakh Compensatory Afforestation Fund Management and Planning Authority or the UT Administration from time to time.
