Public Notice

Subject: Draft of Ladakh Motor Garages (Subordinate) Service Recruitment Rules 2023 - Inviting Comments from Stakeholder thereof.

The Transport Department, UT of Ladakh, has drafted the Ladakh Motor Garages (Subordinate) Service Recruitment Rules for Non-Gazetted posts 2023, vide F.No. A-12018/1/2022-TRANSPORT SECTION/2060, dated: 27.12.2024.

The draft Recruitment Rules were placed in the public domain for 30 days to invite comments from public. In response, we received the following comments/ representations from the stakeholders. Explanations for these comments have been provided for further information & comments from stakeholders.

Representation A:-

A representation was received from Dr. Mohd Jaffer Akhoon, Hon'ble Chairman/Chief Executive Councilor, LAHDC-Kargil, vide No. LAHDC-K/CEC/2023/31/8506, dated: 08.01.2024, expressing concern about the biased distribution of Driver Grade-I posts favoring Leh.

Representation B:-

A representation was received from Drivers Grade II, District Motor Garages, Kargil, dated: 11.01.2024. In this regard the Drivers Grade II working in District Motor Garages, Kargil submit that in the draft 19 posts of Driver Grade-II (L-2) have been kept for DMG Kargil and only 05 posts of Driver Grade-I (L-4) have been kept while as in DMG, Leh and UT Garages post are almost equal which enhances the opportunity of promotion of Driver Grade II to the post of Driver Grade-I. But to their ill luck against 19 posts of Driver Grade II only 05 post of Driver Grade I has been kept which will result in meager chance of promotion avenues to the drivers working in Grade II.

Explanation A&B:-

The distribution of posts is purely based on the post transfer notification issued by J&K, vide SRO 772, dated: 25th October, 2019 transferring 13 posts to Leh and 05 to Kargil. Additionally, there are 14 posts for Driver Grade II in Leh and 19 posts in Kargil.

Representation C:-

A representation was received from Mechanic/Electrician/Welder Diploma Holders of Kargil, requesting direct recruitment for Mechanic/Welder/Electrician/ Blacksmith positions.



Explanation C:-

These positions, each with two vacancies, are intended for existing Helpers' promotion. Direct recruitment would hinder ongoing promotional opportunities for Helpers, leading to the decision to fill the posts through promotion.

Any further comments received within 30 days period will be considered according to rules/instructions.
