 - On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or*
 - He/She is otherwise found ineligible or unsuitable to be retained in the service.*
- The above appointee has been declared medically fit by the Prescribed Medical Authority.*
- This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union territory of Ladakh Motor Vehicle Department (Subordinate) Service Recruitment Rules, 2021.*

It is further ordered that;

1. *The services of the above candidates appointed as **Orderly** is placed at the disposal of the Regional Transport Officer (RTO) Ladakh, Leh for further deployment in the Sub-ordinate Offices of Motor Vehicle Department Ladakh.*
2. *The appointee shall report to the **Regional Transport Officer (RTO) Ladakh**, for joining within a period of one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.*
3. *The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with his /her respective place of posting upon his/ her deployment in the Sub-ordinate Office of **Motor Vehicle Department Ladakh**.*
