Whereas, vide the above referred notification, dated: 20.09.2023, the Leh Autonomous Hill Development Council-subordinate Service Recruitment Board(LAHD-SSRB) has issued a selection list of the 03 candidates against the post of 'Mirab' (Group 'C' Non-Gazetted in Rural Development Department, UT Ladakh, in SL 1 of Pay matrix (Rs. 14800-47100).
