1. The appointees shall be on probation for a period of two years with effect from the date of their joining to the post. During the period of probation,

- the appointee(s) will be liable to be discharged from service at any time without any notice, if:
- a) On the basis of his performance or conduct, he is considered unsuitable for further retention in service, or
- b) He is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Public Works (R&B) Subordinate Service Recruitment Rules, 2021.

- 1. The services of the above candidates appointed as **BEARER/BUTLER** are placed at the disposal of the Chief Engineer, Public Works (R&B)/PMGSY for further deployment in the Sub-Ordinate Offices / Divisions of the Public Works (R&B) Department in Kargil District.
